Dr. Alexandra Brower holds a Doctor of Veterinary Medicine (1996) from the University of Tennessee as well as a B.S. in Chemistry and Biology (1992) from Northland College. She completed a Postdoctoral Fellowship from 1998-2000 at The Johns Hopkins School of Medicine and an additional Postdoctoral Fellowship from 2000-2001 at the University of California, Davis. Dr. Brower is currently a Tenured Professor of Pathology, Chair of Pathology and Population Medicine, and Director of Diagnostic Pathology Center at Midwestern University, College of Veterinary Medicine since July 2016.
